The Commissioner for Trademarks is requested to issue the Certificates of Registration for the pending applications to Assignee.

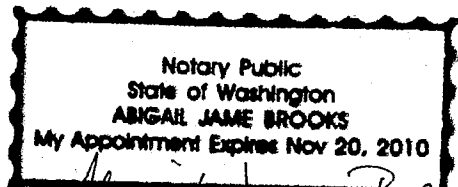


