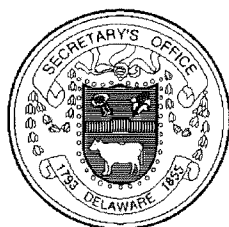

- FIRST: OnVantage and StarCite are the constituent corporations in the Consolidation, and each is a corporation incorporated pursuant to the laws of the State of Delaware.
- SECOND: An Agreement and Plan of Reorganization dated July 19, 2006 by and between OnVantage and StarCite, has been approved, adopted, certified, executed and acknowledged by OnVantage and StarCite in accordance with the provisions of subsection (c) of Section 251 of the Delaware General Corporation Law.
- THIRD: The Resulting Corporation of the Consolidation shall be StarCite, Inc.
- FOURTH: Upon the effectiveness of the Consolidation, the Certificate of Incorporation of the Resulting Corporation shall read as set forth in Exhibit A hereto.
- FIFTH: The executed Agreement and Plan of Reorganization is on file at the principal place of business of the Resulting Corporation at 1650 Arch Street, 18th Flr. Philadelphia, PA 19103.
- SIXTH: A copy of the executed Agreement and Plan of Reorganization will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation of the Consolidation.
- SEVENTH: The Consolidation shall become effective upon filing.
