**TRADEMARK ASSIGNMENT**

This TRADEMARK ASSIGNMENT ("Assignment") is made and entered into as of October 21, 2006, by and between WATTERSON-PRIME HOLDINGS, INC., formerly known Watterson-Prime, Inc., a Washington corporation, ("Assignor"), and FNIS INTELLECTUAL PROPERTY HOLDINGS, INC., a Delaware corporation, ("Assignee").

WHEREAS, Assignor is the sole, unencumbered and exclusive owner of the trademarks and service marks set forth below:

WHEREAS, Assignor desires to assign to Assignee, and Assignee desires to acquire from Assignor, all right, title and interest in and to each of the above-identified trademarks and service marks, including without limitation all common law rights relating thereto, (collectively, the "Marks"), and each of the above-referenced registrations, including without limitation all renewals and extensions that may be granted in connection therewith (collectively, the "Registrations"), together with the goodwill of Assignor's business associated with the Marks and Registrations;

NOW, THEREFORE, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is agreed by the parties hereto as follows:

1. Assignor hereby assigns, sells and sets over to Assignee, all right, title and interest in and to all of the Marks and Registrations therefor, together with all of the goodwill of Assignor's business symbolized by the Marks and Registrations, and all other rights that Assignor has enjoyed thereunder as trademarks, service marks, trade names, domain names and otherwise, including, without limitation, all rights and remedies based upon past infringement of the Marks and/or Registrations (including the right to sue and collect damages and profits for such infringement).

2. Assignor covenants and agrees that it will, at any time, on request, execute and deliver any and all papers that may be reasonably necessary or desirable to perfect the title to the aforementioned assets and rights assigned by this Assignment.
