**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS (the "***Termination and Release***") dated as of June 29, 2007, from GENERAL ELECTRIC CAPITAL CORPORATION with an address located at 201 Merritt 7, PO Box 5201, Norwalk, Connecticut 06851, in its capacity as Collateral Agent (the "***Agent***") for certain banks and other financial institutions (the "***Lenders***"), to Maxim Crane Works, L.P., a limited partnership organized under the laws of the Commonwealth of Pennsylvania (the "***Grantor***").

WITNESSETH:

WHEREAS, pursuant to a Trademark Security Agreement dated as of January 28, 2005 made by the Grantor in favor of the Agent (the "***Security Agreement***"), a security interest (the "***Security Interest***") was granted by the Grantor to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined); and

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on February 4, 2005 at Reel 3022, Frame 0952; and

WHEREAS, the Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:


1. Definitions. The term "***Trademark Collateral***", as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the Trademark Collateral (as defined in the Security Agreement) (including, without limitation, those items listed on Schedule A thereto).

2. Release of Security Interest. The Agent hereby terminates, releases and discharges its Security Interest in the Trademark Collateral without representation, warranty or recourse of any kind or nature.


