ASSIGNMENT NUNC PRO TUNC

This Assignment is entered into by and between Delaware Capital Formation, Inc., a Delaware corporation ("ASSIGNOR"), and UI Holding Co., a Delaware corporation ("ASSIGNEE"), whose address is 33 Broome Corporate Parkway Conklin, New York 13748 as of the 6th day of November, 2006.

WHEREAS, ASSIGNOR, as of the effective date of this assignment, November 6, 2006, owned and had a *bona fide* intention to use the Mark DIMENSIONS (hereinafter "the Mark") in connection with the following goods: computer programs for use in connection with electronic component assembly product lines, namely, process line monitoring and programming software and process line optimization software (Int. Cl. 9);

WHEREAS, ASSIGNOR has applied to register the mark on the Principal Register of the United States Patent and Trademark office based on ASSIGNOR'S *bona fide* intent to use the Mark in commerce in connection with the above-described goods, which application was filed on June 15, 2000 and assigned Serial No. 76071407;

WHEREAS, ASSIGNOR has, through a related company, used the mark in commerce in connection with the goods recited in Serial No. 76071407 since at least as early December 12, 2000;

WHEREAS, by a series of agreements dated November 6, 2006, between related companies of ASSIGNOR and ASSIGNEE, as well as by agreements between ASSIGNOR and ASSIGNEE, all intellectual property rights related to the Mark and the business in connection with which ASSIGNOR has a *bona fide* intention to use the MARK were transferred to a related company of ASSIGNEE and to ASSIGNEE;

WHEREAS, the parties are desirous of confirming the assignment of the intellectual property rights, including the rights to the Mark, described above;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, effective as of November 6, 2006, ASSIGNOR hereby sells, assigns and transfers to ASSIGNEE Nunc Pro Tunc all right, title and interest in and to the Mark and the pending Application therefor, and confirms the transfer by its related company, of the portion of business in connection with which there is a *bona fide* intent to use the Mark, and together with the goodwill of said business for which ASSIGNOR has a *bona fide* intent to use the Mark, including any continuation, reissuance or extension thereof in any jurisdiction, and all rights of priority resulting from the filing of said United States trademark application, and we request the United States Patent and Trademark Office to issue any Registrations granted upon the trademark application set forth above, to UI Holding Co., its successors and assigns.
