2. The Assignor confirms that this Assignment has been made with the goodwill attaching to the Trademark and the goodwill of the business in which the Trademark has been used by the Assignor.

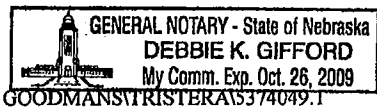
