RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, The Del-Nat Tire Corporation, a Nevada cooperative corporation ("Debtor"), with its principal place of business at 2365 Texas Drive, Memphis, Tennessee 38106 granted a security interest in and lien upon certain trademarks, trademark applications and related rights to Bank of America, N.A., successor to Fleet Capital Corporation, as Agent ("Secured Party") as set forth in the Trademark Security Agreement, dated August 11, 2004, by Debtor in favor of Secured Party (the "Trademark Security Agreement");

1. releases and reassigns to Debtor any and all liens, security interests, right, title and interest of Secured Party pursuant to the Trademark Security Agreement in the trademarks and trademark applications more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind;
2. agrees that any power of attorney or similar rights granted by Debtor to Secured Party pursuant to or in connection with the Trademark Security Agreement is terminated; and
3. authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.


