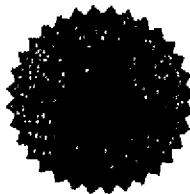

MERGING SITESAFE, LLC INTO
SITE SAFE, INC.**

**(PURSUANT TO SECTION 264 OF THE GENERAL CORPORATION LAW
OF THE STATE OF DELAWARE)**

Site Safe, Inc., a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation has been properly formed pursuant to the General Corporation Law of the State of Delaware. SiteSafe, LLC ("Site Safe") is a Delaware limited liability company.

SECOND: That the Corporation is the wholly-owned subsidiary of its parent company Site Safe, which owns all of the outstanding shares of capital stock of the Corporation.

THIRD: That Site Safe, by resolution of its members, and the Corporation, by resolution of its Board of Directors and by resolution of its sole stockholder, duly approved, adopted, certified, executed and acknowledged the Agreement and Plan of Merger (the "Agreement"), dated August 25, 2000. The Agreement provides for the merger ("Merger") of the Corporation with Site Safe, with the Corporation as the surviving corporation after the Merger.

FIFTH: Upon completion of the Merger, the Corporation will be the surviving corporation. The certificate of incorporation of the Corporation shall be the certificate of incorporation of the surviving corporation after the Merger.

SIXTH: The Agreement is on file and available at the corporate offices of the Corporation and Site Safe which are both located at 200 N. Glebe Road, Suite 1000, Arlington, VA 22203. Any member of Site Safe and any stockholder of the Corporation can receive a copy of the Agreement at no charge upon request.
