WHEREAS, Assignee is the sole shareholder of Assignor,



Assignor authorizes Assignee to collect all outstanding accounts hereby transferred, and to give receipts therefor in Assignor's name, to endorse checks made payable to Assignor, and to take whatever other actions are necessary to secure to Assignee full possession of the properties and assets transferred hereunder.

IN WITNESS WHEREOF, the parties have executed this assignment as of the day and year first written above.


