## SECOND AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT

This Second Amendment to Patent and Trademark Security Agreement (this "Amendment") dated as of July 27, 2007, is by **ENGINEERED DATA PRODUCTS HOLDINGS, LLC** a Delaware limited liability company ("Grantor") in favor of **LASALLE BANK NATIONAL ASSOCIATION**, a national banking association (together with its successors and assigns, the "Secured Party").

### RECITALS

A. Grantor and the Secured Party are parties to that certain Patent and Trademark Security Agreement dated as of May 30, 1997 (as amended, the "Security Agreement").

B. The parties hereto desire to amend the Security Agreement to provide for the attached patents and trademarks to be made a part of the Security Agreement.

**NOW, THEREFORE**, in consideration of the premises hereof, and other financial accommodations to Grantor, and for other good and valuable consideration, the receipt, adequacy and sufficiency of which are hereby acknowledged, Grantor and the Secured Party hereby agree as follows:

1. As used herein and in the Security Agreement, the term "Security Agreement" and "Agreement" shall refer to the Security Agreement as amended by this Amendment. Capitalized terms used herein which are defined in the Security Agreement shall have the meanings provided for in the Security Agreement unless otherwise defined herein.

2. The Security Agreement is hereby amended by adding the schedule attached hereto to the Security Agreement.

3. Grantor certifies that on and as of the date hereof and after giving effect to this Amendment: (i) this Amendment constitutes the legal, valid and binding obligation of Grantor, enforceable against Grantor in accordance with its terms; and (ii) Grantor is the legal and beneficial owner of all of the Collateral, and all of the Collateral is free of any lien, pledge, hypothecation, mortgage, charge, security interest or other encumbrance, except for Permitted Liens.

4. The terms and provisions of this Amendment shall be limited precisely as written and shall not be deemed (a) to be a consent to a modification or waiver of any other term or condition of the Security Agreement; or (b) to prejudice any right or remedy which the Secured Party may now have under or in connection with the Security Agreement. Except as expressly amended hereby, all of the terms and provisions of the Security Agreement shall continue and remain in full force and effect.

5. This Amendment shall be deemed to be a contract made under the laws of the State of Illinois, and the rights and obligations of the parties hereunder shall be construed in

accordance with and be governed by the internal laws of the State of Illinois, without regard to conflicts of law principles.

6. This Amendment may not be amended or modified except by a written instrument executed by the parties hereto. This Amendment may be executed in any number of counterparts, each such counterpart constituting an original but all together one and the same instrument. Telefacsimile signatures shall be deemed to be as legally sufficient as signed originals.
