WHEREAS, ASSIGNEE received from ASSIGNOR all of said right, title and interests in the Scheduled Marks;

WHEREAS, ASSIGNEE is a successor to the business of ASSIGNOR, or a portion thereof, to which the Scheduled Marks pertain, and that business is existing and ongoing;

NOW THEREFORE, in consideration of One Dollar (\$1.00) and other valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby assign, convey, transfer, deliver, set over and vest to and in ASSIGNEE, its successors and assigns, absolutely and forever, this entire right, title and interest, whether statutory or common law, in and to the Scheduled Marks, and all the rights and privileges

related thereto including but not limited to the priority rights arising from said application and mark, the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of past, present and future infringement and dilution, together with that part of the goodwill of the business connected with the use of and symbolized by said Scheduled Marks throughout the world.

ASSIGNOR agrees to execute such further papers and do such other acts as may be necessary to obtain, assign, renew, issue or enforce the aforementioned Scheduled Marks, including, but not limited to any acts which may be necessary, desirable or convenient for claiming said priority rights and perfecting ASSIGNEE's title in the aforementioned Scheduled Marks.


