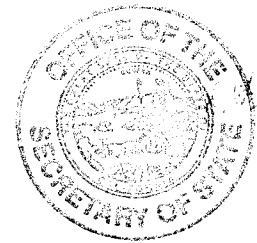
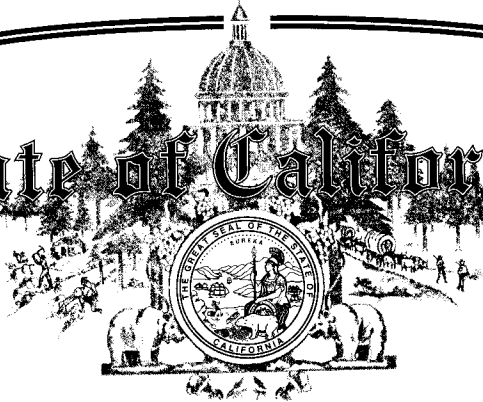

AMENDED AND RESTATED

ARTICLES OF INCORPORATION  
OF  
INTERNET SUPERBRAND, INC.

Eric J. Park and David J. Homsey certify that:

1. They are the President and the Secretary, respectively, of INTERNET SUPERBRAND, INC., a California corporation.
2. The articles of incorporation of the corporation are amended and restated to read in their entirety as follows:

**I. Name**

The name of this corporation is INFORMATION SUPERBRAND, INC.

**II. Purpose**

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business, or the practice of a profession permitted to be incorporated by the California Corporations Code.

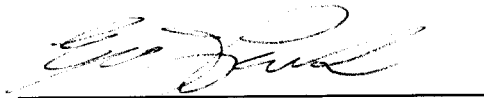
**III. Shares**

The corporation is authorized to issue only one class of shares of stock designated Common stock; and the total number of shares that this corporation is authorized to issue is four hundred million (400,000,000).

3. This Certificate, restating and amending the articles of incorporation, has been approved by the Board of Directors.
4. The amendment was approved by the required vote of the shareholders in accordance with Corporations Code Section 902. The total number of outstanding shares of each class entitled to vote on this amendment was: 11,000,000. The favorable vote of a simple majority of these shares is required to approve the amendment. The number of shares voting in favor of the amendment equaled or exceeded the required vote.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
