ASSIGNMENT OF TRADEMARKS

AND

ACKNOWLEDGMENT OF PAYMENT OF NOTE

This Agreement is dated as of February 4, 1988 and is among LEVI STRAUSS & CO. ("LS&CO."), BATTERY STREET ENTERPRISES, INC. ("BSE"), a wholly-owned subsidiary of LS&CO., and RHE, INC. ("RHE"), a Virginia corporation.

BACKGROUND

LS&CO. is the owner of the trademarks, names and registrations listed on Schedule A hereto ("Trademarks"). In connection with a Purchase Agreement ("Purchase Agreement") dated August 23, 1985 among BSE, RESISTOL SALES, INC., a wholly-owned subsidiary of BSE, MCO, INC. a wholly-owned subsidiary of BSE, and RHE, LS&CO. granted to RHE the right to use and to purchase the Trademarks on the terms and conditions of a License and Assignment Agreement dated October 17, 1985 ("License Agreement") between LS&CO. and RHE.

Also in connection with the Purchase Agreement, RHE executed on October 15, 1985 a Subordinated Note (the "Subordinated Note") in favor of BSE in the principal amount of \$4,338,840. The Subordinated Note is subject to the terms and conditions of a Subordination Agreement dated as of October 1, 1985 (the "Subordination Agreement") among BSE, RHE and MANUFACTURERS HANOVER TRUST COMPANY, a New York banking corporation, whose interest has been assigned to General Electric Credit Corporation.

RHE now desires to purchase and LS&CO. desires to sell the Trademarks. RHE also desires to pay in full all of the principal and accrued interest on the Subordinated Note and BSE desires to receive such payment in consideration for surrendering the Note.

THE PARTIES THEREFORE AGREE AS FOLLOWS:

1. Assignment of Trademarks; Termination of License Agreement

LS&CO. hereby grants and assigns to RHE all of LS&CO.'s right, title and interest in the Trademarks and their registrations, together with the good will of the business pertaining to the Trademarks, in consideration of Two Million Five Hundred Thousand Dollars (\$2,500,000), receipt of which is hereby acknowledged. LS&CO. disclaims any power, rights or continuing

interest in the Trademarks. LS&CO. and RHE hereby terminate the License Agreement effective as of the date hereof.


2. Bank Consent

As required by Section 2.2 of the Subordination Agreement, General Electric Credit Corporation has consented to payment of the Subordinated Note by RHE and such consent is attached hereto as Exhibit A.


3. Acknowledgment of Payment and Delivery of Subordinated Note

BSE acknowledges payment in full by RHE of the principal amount of the Subordinated Note in the amount of \$4,338,840. BSE hereby delivers to RHE and RHE acknowledges receipt of the Subordinated Note marked "PAID" and such Subordinated Note is hereby cancelled and shall be of no further force and effect.


