## TRADEMARK ASSIGNMENT

This Assignment Agreement is by and between Rockaway Bedding, Inc., a New Jersey corporation with places of business at 1578 Sussex Turnpike, Building One, Randolph, New Jersey 07869 and its affiliated entities ("Assignor") and SINT, LLC, a Delaware limited liability corporation with a place of business at 175 Central Avenue South, Bethpage, New York 11714 ("Assignee")

WHEREAS, Assignor is the owner of certain trademarks and trademark registrations, including, but not limited to, those identified in Exhibit A (the "Trademarks");

WHEREAS, Assignor transferred and assigned substantially all of its assets, including the Trademarks, to Sleepy's LLC ("Sleepy's") or one of its designees pursuant to an Asset Purchase Agreement between Assignor and a joint venture comprised of Sleepy's and Hudson Capital Partners, LLC ("Hudson Capital") dated June 13, 2007 and a bankruptcy court order dated July 10, 2007; and

WHEREAS, Assignee is an affiliate of Sleepy's and desires to acquire all right, title and interest in and to the Trademarks.

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns to Assignee, all of Assignor's right, title and interest in and to the Trademarks, together with the business, or portion thereof, to which the Trademarks pertain, the goodwill symbolized by use of the Trademarks, and the right to sue third parties for and recover damages from past and future infringement of the Trademarks.

All covenants and obligations herein shall be binding on and inure to the benefit of the Assignor, Assignee and their respective successors and permitted assigns.

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Trademarks to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.
