RELEASE OF SECURITY INTEREST IN TRADEMARK

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 24, 2007 ("Release"), is by WACHOVIA CAPITAL FINANCE CORPORATION (CENTRAL), in its capacity as Agent for itself and certain other lenders (in such capacity, hereinafter referred to as the "Assignor"), in favor of HUFFY SPORTS DELAWARE, INC., a Delaware corporation (the "Assignee"). Capitalized terms not otherwise defined herein have the meanings set forth (or incorporated) in the Trademark Security Agreement (as defined below).

WHEREAS, pursuant to the Trademark Collateral Assignment and Security Agreement, dated as of May 22, 2006, by and among Assignee and Assignor (as amended, the "Trademark Security Agreement"), Assignee, among other things, collaterally assigned to the Assignee, for the benefit of itself and certain other lenders, a continuing security interest in all of such Assignee's right, title and interest in and to the trademarks identified on Exhibit A hereto (collectively, the "Trademarks").

WHEREAS, (i) the Trademark Security Agreement was recorded in the United States Patent and Trademark Office as of October 16, 2006, at Reel 003409, Frame 0491 and (ii) a Corrective Assignment with respect to the Trademark Security Agreement was recorded in the United States Patent and Trademark Office as of October 18, 2006, at Reel 003410, Frame 0952.

WHEREAS, Assignor has agreed to (i) release its security interest in the Trademarks and the goodwill of the business symbolized by the Trademarks (collectively, the "Released Collateral"), and (ii) assign, transfer and grant any and all of its right, title and interest in the Released Collateral to Assignee without representation or warranty of any kind, nature or description.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby releases its security interest in the Released Collateral, and reverts Assignee with any and all of Assignor's right, title, and interest in, to and under the Released Collateral, without representation or warranty of any kind, nature or description.



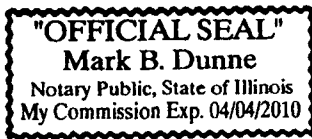
