**RELEASE OF SECURITY INTEREST**

This RELEASE OF SECURITY INTEREST is granted as of August 29, 2007 by Wells Fargo Foothill, Inc. (the "Trustee"), a California corporation, located at 2450 Colorado Avenue, Suite 3000 West, Santa Monica, California 90404;

WHEREAS, pursuant to a Trademark Security Agreement dated January 16, 2003, Pretzelmaker, Inc. ("Pretzelmaker") granted a continuing security interest to the Trustee's predecessor in interest, Foothill Capital Corp., in all of Pretzelmaker's rights, title and interest in and to U.S. Trademark Registration No. 2,883,057 (WRAPZEL) (referred to herein as "the WRAPZEL Trademark"); and

WHEREAS, the security agreement of January 16, 2003 was recorded with the U.S. Patent and Trademark Office on January 16, 2003 at Reel 2653/Frame 0561; and

WHEREAS, with respect to the agreement of January 16, 2003 and any prior security agreements, the Trustee wishes to release all rights, title and interests in and to the WRAPZEL Trademark and to dissolve any and all liens, rights, interests and encumbrances respecting the WRAPZEL Trademark;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Trustee hereby waives, releases, restores, discharges, quit claims, relinquishes and abandons any and all rights, title and interests charged to it, liens, security interests, and any and all claims of liens or security interests and any other claim of encumbrances, rights, title, interests or goodwill, of any kind or nature whatsoever, in and to the WRAPZEL Trademark by the agreement dated January 16, 2003 and by any prior security agreements.

This Release of Security Interest shall be binding upon the Trustee and its successor and assigns.
