This Amended and Restated Termination and Release of Security Interest, (this "Release") dated as of July 25, 2007, made by UBS AG, Stamford Branch, as Collateral Agent (the "Collateral Agent"), in favor of Travelport, Inc. ("Travelport").

R E C I T A L S :

SECTION 1.1. Collateral Agent recorded a security interest as to trademarks and trademark applications with the Trademark Division of the United States Patent & Trademark Office on October 19, 2006, at Reel 003412, Frame 0025.

SECTION 1.2. Travelport for Business, Inc. assigned the trademarks and trademark applications identified on Schedule A to Travelport, as recorded with the Trademark Division of the United States Patent & Trademark Office on March 6, 2007, at Reel 3499, Frame 0390.

SECTION 1.3. Travelport has requested Collateral Agent to release, and Collateral Agent has agreed to release, its lien on such trademarks and trademark applications.

SECTION 1.4. Collateral Agent recorded a release against the trademarks and trademark applications listed in Schedule A hereto and certain other trademarks and trademark applications dated July 25, 2007 with the Trademark Division of the United States Patent & Trademark Office on July 31, 2007 at Reel 3589, Frame 0534 ("Original Release"). The Original Release was in favor of Travelport for Business, Inc.

SECTION 1.5. Travelport now desires to amend Schedule A to the Original Release so as to delete from that Schedule trademarks and trademark applications which are now owned by Travelport pursuant to the assignment referred to in Section 1.2 above.






