RELEASE OF SECURITY INTEREST
IN TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK SECURITY AGREEMENT (this "**Release**") is made as of April 20, 2007, by **ANTARES CAPITAL CORPORATION**, as Agent ("**Antares**") in favor of **AIRPAX CORPORATION, LLC**, a Delaware limited liability company ("**Grantor**").

W I T N E S S E T H:

WHEREAS, Antares and Grantor were parties to that certain Trademark Security Agreement, dated as of May 14, 2004 (the "**Security Agreement**"), pursuant to which Grantor granted a security interest to Antares in certain Trademark Collateral (as defined in the Security Agreement) as security for certain obligations owing by Grantor to Antares; and

WHEREAS, the Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on May 24, 2004, at Reel 2972, Frame 0044; and

WHEREAS, Grantor has requested that Antares release and terminate its security interest in the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Antares hereby releases and terminates any and all security interest in the Trademark Collateral (including, without limitation, the trademarks and trademark applications set forth on Schedule 1) granted to Antares by Grantor pursuant to the Security Agreement.
2. Antares hereby reassigns, grants and conveys to Grantor, without any representation by Antares, all of Antares' right, title and interest in and to the Trademark Collateral.
3. Antares shall provide Grantor with any information and additional authorization, and shall execute any documents necessary to effect, record, and perfect this Release.
