RELEASE OF TRADEMARK SECURITY INTEREST

or unfair competition regarding the same, and granted to the Agent by the Assignor by the Security Agreement, which Assignment was duly recorded on December 31, 1997 at Reel 1679, Frame 0770 in the United States Patent and Trademark Office.
