**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**  
dated as of August 29, 2007, by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national association, located at MAC C7300-210, 1740 Broadway, Denver, Colorado 80274 (the "Secured Party"), acting through its Wells Fargo Business Credit operating division, successor-in-interest to Norwest Business Credit, Inc.

**WHEREAS**, R.A.M. Associates, Inc., a Colorado corporation, now know as Classic Sport Companies, Inc., (the "Grantor") and the Secured Party entered into a Trademark Security Agreement, dated as of March 20, 1998 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on April 27, 1998, at Reel 1723, Frame 0388 and which a security interest was recorded with the United States Patent and Trademark Office on April 27, 1998, at Reel 1713, Frame 0187 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

The Patents and the Trademarks are referred to herein collectively as the "Intellectual Property"; and

**WHEREAS**, the Secured Party has agreed to terminate and release its Security Interest (as defined in the Security Agreement) in the Intellectual Property as herein provided:

**NOW, THEREFORE**, for valuable consideration the Secured Party hereby terminates and releases its Security Interest (as defined in the Security Agreement) in the Intellectual Property, including, without limitation, the Patents listed on Exhibit A hereto and the Trademarks listed on Exhibit B hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above
