AMENDMENT TO TRADEMARK ASSIGNMENT AGREEMENT

THIS AMENDMENT TO THE TRADEMARK ASSIGNMENT AGREEMENT (the "Amendment") is dated as of December 12, 2006 by and among Cytec Surface Specialties Germany GmbH & Co. KG, Cytec Surface Specialties S.A., Cytec Surface Specialties Inc. and Cytec Surface Specialties Austria GmbH, Cytec Industries Inc., a Delaware corporation and INEOS Americas LLC, an Alabama limited liability company (each a "party" and collectively, the "Parties"). Capitalized terms used and not otherwise defined herein have the meanings set forth in the Agreement (as defined herein).

WHEREAS, a Trademark Assignment Agreement (the "Agreement") was executed and effective as of August 31, 2005 by and among Cytec Surface Specialties Germany GmbH & Co. KG, Cytec Surface Specialties S.A., SURF CHIP, Inc. and Cytec Surface Specialties Austria GmbH, all wholly-owned subsidiaries of Cytec Industries, Inc. (collectively, the "Assignors") and INEOS Americas LLC ("Assignee");

WHEREAS, the Assignors under the Agreement are Cytec Surface Specialties Germany GmbH & Co. KG, Cytec Surface Specialties S.A., SURF CHIP, Inc. and Cytec Surface Specialties Austria GmbH;

WHEREAS, in the Agreement, Cytec Industries Inc. was merely indicated as the parent of the Assignors and was neither the owner nor intended to be interpreted as an Assignor; and

WHEREAS, SURF CHIP, Inc. was merged into Cytec Surface Specialties Inc. effective as of December 31, 2005 which merger was recorded in the U.S. Patent and Trademark Office in connection with the Marks of SURF CHIP, Inc. on January 16, 2006.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. The Parties agree that the Preamble of the Agreement is hereby amended and restated as follows:

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is dated as of August 31, 2005, by and among Cytec Surface Specialties Germany GmbH & Co. KG, Cytec Surface Specialties S.A., SURF CHIP, Inc., now known as Cytec Surface Specialties Inc., and Cytec Surface Specialties Austria GmbH (collectively, the "Assignors"), (all the aforesaid Assignors being wholly-owned subsidiaries of Cytec Industries Inc., a Delaware corporation) and INEOS Americas LLC, an Alabama limited

liability company ("Assignee") (each a "Party" and collectively, the "Parties").

2. This Amendment together with Agreement contains the entire agreement and understanding by and between the Parties and no representations, promises, agreements or understandings, written or oral, not contained herein shall be of any force or effect. The terms of the Agreement which are not expressly amended by this Amendment shall survive and remain in full force and effect.
