**Trademark Assignment**

**WHEREAS**, Atlantic Bank of New York, a New York corporation with a principal place of business at 960 Avenue of the Americas, New York, New York 10001 ("Assignor"), has adopted, owns and is using the mark ATLANTIC BANK and the mark comprised of three spirals, as depicted on Exhibit A hereto (together, the "Marks");


**WHEREAS**, Assignor has used its ATLANTIC BANK mark in connection with banking and financial services in International Class 36 since at least as early as 1971 and has used its three spirals mark in connection with banking and financial services in International Class 36 since at least as early as 1988;

**WHEREAS**, Assignor is the owner of federal trademark Registration No. 1,533,587 for the mark ATLANTIC BANK, registered April 4, 1989 and Registration No. 1,513,918 for the mark comprised of three spirals, registered November 22, 1988 (*see Exhibit B*) (the "Registrations") for the Marks on the Principal Register of the United States Patent and Trademark Office in connection with the goods/services identified therein; and

**WHEREAS**, New York Community Bancorp, Inc. ("Assignee") desires to acquire all rights in and to the Marks, including the common law rights, the Registrations, and the goodwill associated therewith.


