TO THE
CERTIFICATE OF INCORPORATION

CaseShare Systems, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "General Corporation Law"), hereby certifies as follows:

- I. The present name of the Corporation is CaseShare Systems, Inc. The Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware on January 24, 2005 under the name of CaseShare Systems, Inc.
- II. On August 17, 2006 the Stockholders of the Corporation adopted an amendment to the Certificate of Incorporation of the Corporation in accordance with the provisions of Section 242 of the General Corporation Law whereby:

Article I of the Certificate of Incorporation was deleted in its entirety, and in its place the following was substituted:

"ARTICLE I

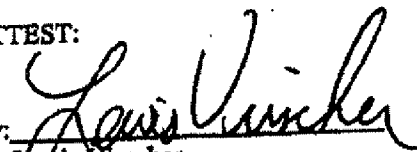
The name of the corporation (hereinafter, the "Corporation") is Catalyst Repository Systems, Inc."
