**ASSIGNMENT OF TRADEMARKS AND DOMAIN NAME**

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, effective as of August 10, 2007 (the "Effective Date"), Assignor hereby conveys, assigns, transfers, and delivers to Assignee, the entire right, title and interest in and to the Marks and Domain Name together with all rights and privileges granted and secured thereby, including (1) the goodwill of the business associated therewith; (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Marks and Domain Name, including without limitation damages and claims for past or future infringements, dilution, misappropriation and any other violations of the Marks and Domain Name; and (3) all rights of Assignor to sue for past, present and future infringements or misappropriation of the Marks and Domain Name.

Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks and Domain Name.
