ASSIGNMENT OF MARKS

WHEREAS, in accordance with Section 6.3(a)(vii) of the Purchase Agreement, Sellers are required to provide this Assignment to Buyer.

NOW, THEREFORE, for one dollar (\$1.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, each Seller hereby transfers, sells and assigns to Buyer, all right, title and interest in and to all Marks owned by such Seller and used in connection with the Businesses, including but not limited to those set forth in **Schedule 1** attached hereto, together with the goodwill of the Businesses connected with the use of such Marks. Each Seller further assigns to Buyer all claims for damages by reason of past, present or future infringement or other unauthorized use of the Marks and the right to sue for, and collect the same.

Each Seller hereby authorizes the Commissioner of Patent and Trademarks and any other official or organization whose duty it is to assign and/or maintain any of the Marks to record Buyer as the assignee and owner of all Marks currently in the name of such Seller.


