ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (this "Trademark Assignment") made effective August 31, 2007 (the "Effective Date") between Value Engineered Products, Inc., a Wisconsin corporation ("Assignor") and Methode Electronics, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the VALUE ENGINEERED PRODUCTS, INC. trademark as described in United States Trademark Registration No. 1,450,351 and all common law rights associated therewith (the "Assigned Trademark"), together with the goodwill of the business connected with and symbolized thereby; and

WHEREAS, Assignor wishes to assign and transfer to Assignee all right, title and interest in and to the Assigned Trademark and the goodwill symbolized thereby.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are acknowledged, the parties hereby agree as follows.

Assignor hereby contributes, assigns, transfers and conveys to Assignee the entire worldwide right, title, interest in and to the Assigned Trademark together with the goodwill of the business connected with and symbolized thereby, the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made.

From and after the Effective Date, Assignor shall promptly, and in any event within ten (10) business days, change its corporate name to a name that does not include the VALUE ENGINEERED PRODUCTS, INC. trademark or any other matter confusingly similar to the Assigned Trademark.

This Trademark Assignment shall be governed by and construed in accordance with the laws of the State of Illinois without regard to conflict of laws principles.


