**TRADEMARK OWNERSHIP AGREEMENT**

This Agreement is made on the 9th day of March, 2007, between FMC CORPORATION, a Delaware corporation, with an address at 1735 Market Street, Philadelphia, Pennsylvania 19103 ("ASSIGNOR") and NIPPON SODA CO., LTD, of Ohtemachi 2-chome, Chiyoda-ku, Tokyo 100-8165, Japan ("ASSIGNEE"), and

WHEREAS, ASSIGNOR has adopted and registered the trademark TRANSPORT, U.S. Registration No. 3,121,718 ("TRADEMARK"), and has also adopted the figure trademark that has been described in attached paper 1. ("FIGURE TRADEMARK");

WHEREAS, ASSIGNOR and ASSIGNEE have entered into a distributorship agreement of May 12, 2004 concerning the product(s) to be sold under certain trademarks ("Distributorship Agreement"), and

WHEREAS, ASSIGNEE is desirous of acquiring the TRADEMARK and FIGURE TRADEMARK and all rights that ASSIGNOR has obtained in the TRADEMARK and FIGURE TRADEMARK.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows.

**1. Assignment of TRADEMARK and FIGURE TRADEMARK**

ASSIGNOR does assign and transfer to ASSIGNEE, its successors and assigns, all its right, title, and interest in and to the TRADEMARK and FIGURE TRADEMARK, together with the goodwill of the business symbolized by and associated with the TRADEMARK and FIGURE TRADEMARK and TRADEMARK registration thereof.

**2. Procedure**

The ASSIGNEE shall take all necessary procedures to assign and change the owner's name of the TRADEMARK from the ASSIGNOR to the ASSIGNEE at the U.S. Patent and Trademark Office. The ASSIGNOR shall, whenever requested by the ASSIGNEE, reasonably cooperate with the ASSIGNEE in all matters that the ASSIGNEE may reasonably deem necessary. The ASSIGNEE takes all necessary procedures for the registration of the FIGURE TRADEMARK if necessary.

**3. Design Marks and Trade Dress other than the FIGURE TRADEMARK**

As used in this Agreement, the term "DESIGN MARKS" is defined to include all designs and trade dress other than the FIGURE TRADEMARK and slight modifications to the FIGURE TRADEMARK that ASSIGNEE may make, such as changing the color and removing elements of the FIGURE TRADEMARK.

ASSIGNOR and ASSIGNEE agree that, notwithstanding any provisions to the contrary in the Distributorship Agreement, ASSIGNEE shall have no right to DESIGN MARKS adopted by, used or otherwise owned by ASSIGNOR now or in the future, including without limitation, those used by ASSIGNOR with any of the products sold under the Distributorship Agreement, including the TRADEMARK. For avoidance of doubt, this provision does not affect ASSIGNEE's ownership of the TRADEMARK and FIGURE TRADEMARK as transferred to ASSIGNEE under this Agreement.

IN TESTIMONY WHEREOF, ASSIGNOR and ASSIGNEE have executed this agreement by their duly authorized officials.
