Each of NYSE Merger Corporation Sub, Inc., a Delaware corporation ("NYSE Merger Corporation") and NYSE Merger Sub LLC, a New York limited liability company ("NYSE Merger Sub"), hereby certifies the following information relating to the merger (the "Merger") of NYSE Merger Corporation Sub with and into NYSE Merger Sub:

FIRST: The names and states of incorporation of the constituent business entities (the "Constituent Business Entities") in the Merger are:

SECOND: (A) The initial articles of organization of NYSE Merger Sub were filed with the Department of State of the State of New York on July 14, 2005.

THIRD: Each of the Constituent business entities has entered into, executed and approved an Agreement and Plan of Merger, dated as of April 20, 2005, as amended and restated as of July 20, 2005, and as further amended on October 20, 2005 and November 2, 2005 (the "Merger Agreement"), setting forth the terms and conditions of the Merger.

FOURTH: The business entity surviving the Merger (the "Surviving Business Entity") is NYSE Merger Sub, the name of which, as of the effective time, shall hereby be changed to New York Stock Exchange LLC.

FIFTH: The Merger shall be effective on March 7, 2006.

SIXTH: The Surviving Business Entity does hereby irrevocably designate the Secretary of State of the State of New York as agent of the Surviving Business Entity upon whom process against it may be served. The post office address within or without the State of New York to which the Secretary of State of the State of New York shall mail a copy of any

EIGHTH: The executed Merger Agreement is on file at the principal place of business of the Surviving Business Entity whose address is c/o New York Stock Exchange, 11 Wall Street, New York, NY 10005.

NINTH: A copy of the Merger Agreement will be furnished by the Surviving Business Entity, on request and without cost, to any member or any person holding an interest in any Constituent Business Entity.
