I4 Commerce Inc., a corporation organized and existing under and by virtue of the provisions of the General Corporation Law of the State of Delaware (the "General Corporation Law"),

DOES HEREBY CERTIFY:

FIRST: That the name of this corporation is I4 Commerce Inc. and that this corporation was formerly known as GoPin Inc. and was originally incorporated pursuant to the General Corporation Law on May 15, 1998 under the name K&B Networks Inc. (hereinafter, the "Corporation").

SECOND: That the Board of Directors of the Corporation adopted resolutions setting forth a proposed amendment to the Eleventh Amended and Restated Certificate of Incorporation of the Corporation (the "Restated Certificate"), declaring said amendment to be advisable and in the best interests of the Corporation and its stockholders and authorizing the appropriate officers of the Corporation to solicit the consent of the stockholders therefor, which resolution setting forth the proposed amendment is substantially as follows:

RESOLVED, that Article I of the Restated Certificate be deleted and replaced in full with the following:

"The name of this corporation is Bill Me Later, Inc."

THIRD: That thereafter said amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the stockholders holding the requisite number of shares required by statute given in accordance with and pursuant to Section 228 of the General Corporation Law.
