## AFFIDAVIT


I, Adam Janeczek the undersigned, being duly sworn, do depose and say that:

1. I am of age, competent to testify and have personal knowledge of the following records.
2. I am a Staff Attorney for Colt Defense LLC ("Defense") a Delaware limited liability company having offices at 547 New Park Avenue, West Hartford, CT 06110-1332, P.O. Box 118, Hartford, CT 06141-0118.
3. Defense is the owner of the Trademark "AR-15" (reg. 825,581) (the "Mark").
4. This Affidavit is being submitted to the United States Patent and Trademark Office to clarify the nature of certain assignments of the Mark that were executed on March 13, 1990 and March 22, 1990.
5. On March 13, 1990, CFPI Inc. ("CFPI") executed two contracts to assign all of its rights and interests in the Mark to Colt Licensing Limited Partnership ("CLLP") in consideration for a limited partnership profits interest in CLLP.
6. As a result of the March 13, 1990 assignment, CLLP was a wholly owned by its general partner CII Holdings Inc. ("CII"), and CFPI as its limited partner.
7. On March 22, 1990, CF Holding Corp ("Holding") entered into an asset purchase agreement dated November 28, 1989 and restated as of March 22, 1990 (the "Agreement") with CFPI and CII, under which Holding was given the assignable right to purchase the general and limited partnership profits interests in CLLP.
8. On March 22, 1990, Holding exercised its rights under the Agreement to assign its right to purchase the general partnership profits interests in CLLP by assigning the right to purchase those interests to CF Intellectual Property Corp. ("Corp").  
  
On March 22, 1990, Holding exercised its rights under the Agreement to assign its right to purchase the limited partnership profits interests in CLLP by assigning the right to purchase those interests to CF Intellectual Property Limited Partnership ("CF Partnership").
10. On March 22, 1990, Corp exercised the right to purchase the one percent (1%) general partnership profits interests in CLLP.

On March 22, 1990, CF Partnership exercised the right to purchase the ninety-nine percent (99%) of the limited partnership profits interests in CLLP.

12. On March 22, 1990, Corp assigned its entire interest in the Mark to CF Partnership.

I declare that to the best of my knowledge, information and belief the facts contained herein are true and correct this 5 day of September 2007.
