Assignor does further agree to execute and deliver without further consideration any further applications, assignments and documents, and to perform such other acts as may be deemed necessary by Assignee, its successors, assigns, and nominees, fully to secure Assignee's interest as aforesaid and to obtain or maintain Trademark registrations in any and all countries.
