The undersigned hereby certifies that the following resolutions were duly adopted by the sole stockholder and all of the directors of Elgar Electronics Corporation (the "Company").

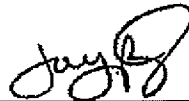
**RESOLVED**, that Article 1 of the Certificate of Incorporation of the Company is hereby amended in its entirety to read as follows:
