**RELEASE OF SECURITY INTEREST IN TRADEMARK**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK (this "Release") is made as of August 30, 2007, by LASALLE BUSINESS CREDIT, LLC, a Delaware limited liability company, as agent ("Agent") for itself and various other lenders ("Lenders"), in favor of NEW CREATIVE ENTERPRISES, INC., an Ohio corporation ("Borrower").

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of December 9, 2004 made by Borrower in favor of Agent for the benefit of Lenders (as amended, restated, modified or supplemented and in effect from time to time, the "Trademark Security Agreement"), Borrower granted a security interest in certain of its trademarks and service marks to Agent for the benefit of Lenders to secure certain debt and obligations owing from Borrower to Agent and Lenders;
