## TRADEMARK ASSIGNMENT

This ASSIGNMENT is effective as of September 12, 2007, between Lincoln Global, Inc., a Delaware corporation, located at 1200 Monterey Pass Road, Monterey Park CA, 91754 (hereinafter "Lincoln Global"), and J.W. Harris Co., Inc., an Ohio corporation, located at 4501 Quality Place Mason, OH 45040 (hereinafter "J.W. Harris").

WHEREAS, Lincoln Global represents that (i) it is the owner of all rights, title and interest in and to the following trademarks and trademark registrations and the goodwill associated therewith (collectively, the "Marks"):


(ii) its title in and to the Marks is free of any and all encumbrances, liens or other adverse claims, (iii) said Marks have not been the subject of any license from or to any third party, and (iv) it has the authority and right to make this assignment, and that the making of this assignment will not violate or interfere with the rights of any third party.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lincoln Global hereby assigns absolutely to J.W. Harris and its successors and assigns all of its right, title and interest in and to the Marks, together with the goodwill of the business associated with, corresponding to, symbolized by and embodied in said Marks, U.S. Trademark Registration Nos. 913,433, 1,730,056, and 1,013,432, and all common law rights in the Marks, as well as the right to commence an action for past or future infringement.

Lincoln Global undertakes that:

- (a) It will perform all acts and execute all documents necessary or desirable for further assuring the right, title and interest to the Marks in J.W. Harris, including the corresponding goodwill, and to U.S. Registration Nos. 913,433, 1,730,056, and 1,013,432, and will cooperate with J.W. Harris to record this Assignment with the United States Patent and Trademark Office, if requested;
- (b) It will not commit any act, matter or thing that may directly or indirectly challenge, prejudice or invalidate the Marks, their use or registration by J.W. Harris, its successors and assigns, or this assignment to J.W. Harris.
