NOTICE OF SECURITY INTEREST
U.S. TRADEMARKS

WHEREAS, R. H. Kuhn Company, Incorporated, a Pennsylvania corporation (the "Grantor"), has adopted, used and is using the United States trademarks listed on the annexed Schedule A, which trademarks are registered in or subject to the trademark applications filed in the United States Patent and Trademark Office (the "Trademarks");

WHEREAS, pursuant to a certain Credit Agreement, dated of even date herewith, by and among the Grantor, the other Borrowers party thereto, the other Guarantors party thereto, PNC Bank, National Association ("PNC Bank"), and various other financial institutions party thereto from time to time (PNC Bank and such other financial institutions are each a "Bank" and collectively, the "Banks"), PNC Bank, as agent for the Banks (in such capacity, the "Agent"), (as further amended, restated, modified or supplemented from time to time, the "Credit Agreement"), the Grantor has entered into that certain Patent and Trademark Security Agreement, dated of even date herewith (the "Security Agreement") in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement, the Guarantor has granted to the Agent (for itself and for the benefit of the Banks), a mortgage on, pledge of and security interest in, all right, title and interest of the Grantor in and to the Trademarks, together with all the goodwill of the business symbolized by the Trademarks, and the registrations or applications for registration thereof, and all proceeds thereof, including, without limitation, any royalties, claims for infringement and proceeds of sale or other disposition thereof (the "Trademark Collateral") to secure the payment and performance of the Obligations (as defined in the Credit Agreement).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, the Grantor does hereby confirm its grant to the Agent (for itself and for the benefit of the Banks) of a mortgage on, pledge of and security interest in the Trademark Collateral to secure prompt payment and performance of the Obligations.


