WHEREAS, Assignee is desirous of obtaining and Assignor wishes to assign, grant and deliver exclusively to Assignee all rights, titles and interests of every kind and nature in and to the Trademark and Application, together with the goodwill associated therewith;

NOW THEREFORE, in consideration for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns all rights, title and interest in and to the Trademark and Application, together with the goodwill associated therewith and with the right to recover for damages and profits and all other remedies for past infringements thereof.
