ASSIGNMENT

This Assignment ("Assignment") is made effective *nunc pro tunc* as of **August 20, 2007** from Central Mfg. WHEREAS, ASSIGNOR is the owner of the trademarks listed below and other alleged unregistered trademark rights ("the Marks", specified below), together with whatever goodwill of the business is symbolized thereby in connection with the goods or services on which the Marks were, are, or may have been used ("the Products"), and licenses to third parties for use of trademarks and other property, whether tangible, intangible, known or unknown ("the Property"):

- A. The common law trademark rights, US and any foreign registrations, and goodwill in TRAVEL NURSE (Reg. No. 2847015), RENTAMARK (Reg. No. 2371075), DARK STAR (Reg. No. 2564888), TRIANA (Reg. Nos. 2627054, 2629600, 2264642, 2320324, 2287397, 2264631, and 2266783), SENTRA (Reg. No. 2140524), STEALTH (Reg. No. 3038587 and Serial No. 75423924) and DARK STAR LAGER (Reg. No. 1903753) for the goods or services identified in each registration,
- B. Any registered or unregistered trademark rights whose use inured to the benefit of ASSIGNOR by way of third party license or contract for the goods or services identified in the Marks; and
- C. All claims in any pending TTAB opposition, TTAB cancellation or judicial proceeding that involved the Marks and/or the Property including the right to recover for any past infringement of any right therein;

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Marks and the Property, including the right to recover for any past infringement thereof, and any and all tangible and intangible assets, claims, and rights held in the name of ASSIGNOR.


NOW, THEREFORE, in consideration of the payment of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest of whatever kind in and to the Marks, the Property and any and all tangible and intangible assets, claims, and rights held in the name of ASSIGNOR, together with (1) whatever goodwill of any business relating to the Products in respect upon which the Marks are used and for which they are registered: (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks: and (3) all rights to sue for past, present and future infringements or misappropriations of the Marks.

ASSIGNOR further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing , completing, or vesting in ASSIGNEE full right, title, and interest in the Marks and the Property.


