WHEREAS, Med-Vantage has filed applications for the copyrights listed on Exhibit B hereto (the "Copyrights") with the United States Copyright Office (the "USCO");

WHEREAS, the Copyrights are either registered with, or currently pending before, the USCO;

WHEREAS, Med-Vantage executed an Affidavit and Recordation of a Security Interest (the "Affidavit"), which perfected a security interest in the Copyrights in favor of BCBSMA, and filed the Affidavit with the USCO on or about June 9, 2007; and

WHEREAS, BCBSMA desires to terminate and release the entirety of its security interest in both the Marks and the Copyrights effective as of the day and year first above written.


