TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") shall be effective as of the 29th day of September 2006 (the "**Assignment Date**") by and between EDS Canada Inc., a Canadian company incorporated in Ontario, with its principal place of business at 33 Yonge Street, Suite 500, Toronto, Ontario M5E 1G4 CANADA (hereinafter "**Assignor**") and Electronic Data Systems Corporation, a Delaware corporation with its principal place of business at 5400 Legacy Drive, H3-3A-05, Plano, Texas 75024 (hereinafter "**Assignee**"); and

WHEREAS, the Assignor is a wholly owned subsidiary of E.D.S. World Corporation (Netherlands), a Texas company (hereinafter "**EDS WCN**"); and

WHEREAS, Assignor owned all of the shares of Insurance Software Solutions Corp., a Canadian company incorporated under the laws of the Province of Ontario ("**Solcorp**"), and effective December 31, 2005, Solcorp distributed all of its assets and liabilities to Assignor in a complete liquidation (the "**Liquidation**"); and

WHEREAS, pursuant to the Liquidation, Assignor became the owner of certain software, and the trademark applications and/or registrations, brand names and logos listed on the attached Exhibit "A", attached hereto and incorporated herein (hereinafter "**Trademarks**"); and

WHEREAS, pursuant to a Unanimous Written Consent of the Board of Directors of the Assignor, dated September 28, 2006, the Assignor distributed certain of Solcorp's tangible and intangible assets to EDS WCN including software consisting of Ingenium, ProductXpress and Radiance program source codes (the "**Solcorp Software**"); and

WHEREAS, EDS WCN further assigned the Solcorp Software to the Assignee hereunder pursuant to an Assignment and Assumption Agreement dated September 29, 2006; and

WHEREAS, the assignment of the Solcorp Software to both EDS WCN and the Assignee was intended to include the Trademarks and the parties hereto wish to clearly document such intent; and

WHEREAS, to complete the purpose and intent of the assignment of the Solcorp Software, Assignor desires to assign its right, title and interest in, to and under the Trademarks, including any goodwill associated therewith, all registrations therefore, all common law rights therein and any and all rights related thereto to Assignee; and

WHEREAS, Assignee desires to acquire the Trademarks;


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:


