Pursuant to Section 242 of the Delaware General Corporation Law it is hereby certified that:

1. The name of the corporation (hereinafter, the "Corporation") is PAI/UII Acquisition Corp.

2. The Certificate of Incorporation of the Corporation, as currently in effect, is hereby amended by deleting Article FIRST in its entirety and replacing it with the following Article FIRST:
