## ASSIGNMENT AGREEMENT

THIS ASSIGNMENT (the "Assignment") shall be deemed made and entered into nunc pro tunc as of the 30th day of June, 2007, ("Effective Date") by and between NHN Corporation, a Korean corporation, located at 9th Flr Venture Town Bldg, 25-1, Jeongja-dong, Bundang-gu, Seongnam-City, Gyeonggi, Korea ("Assignor"), and NPLUTO Corporation, a Korean corporation, located at 9Fl. NOW, THEREFORE, for \$1.00 and other valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor assigns to Assignee its entire worldwide right, title and interest in and to the Mark together with the goodwill of the business in connection with which the Mark is used, including all registrations and applications therefore, as well as all renewals and extensions of registrations that are or may be secured by Assignee, its successors, assigns or other legal representatives, including, without limitation, all claims for damages by

reason of past, present and future infringement or other unauthorized use of the Mark, with the right to sue for damages, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

Assignor hereby covenants and agrees that it will execute any and all instruments and documents reasonably necessary to aid the Assignee, its successors, legal representatives, and assigns, in the implementation and perfection of this Assignment.
