**TERMINATION OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 31, 2007, is made by Bank of America, N.A., as Administrative Agent (the "Secured Party").
