TRADEMARK ASSIGNMENT

This Assignment of the Service Mark "DISCLOSE" Assignment ("Assignment") is made and entered into as of September 24, 2007, by and between Intellectual Property Holdings, Inc., a Delaware corporation (the "Assignor"), and Enis Intellectual Property Holdings, Inc., a Delaware corporation (the "Assignee").

The Assignor has created, developed, adapted and is using in commerce the trademark DISCLOSE (PL) and the associated service mark in connection with new letters, forms, charts, booklets and brochures addressing environmental and/or real estate (commercial and residential) real estate services, namely, providing environmental services for others, in connection with recording and reporting natural and man-made environmental conditions and residential real estate real estate services, namely, preparing and providing environmental and regulatory compliance information for real estate real estate services, providing environmental information regarding hazardous property conditions and environmental conditions; real estate services, namely, research and due diligence in connection with the sale, lease and purchase of real estate and related goods and services.

The Assignor hereby desires to assign to Assignee, and Assignee desires to acquire from Assignor, all of Assignor's interest in and to the Mark and Registrations, along with the goodwill associated with the Mark and Registrations.

Assignor has received from Assignee, in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged.

Assignor hereby assigns, sells and conveys over to Assignee, all of Assignor's right, title and interest in and to the Mark and Registrations, together with the goodwill of Assignor's business associated with the Mark and Registrations, and all other rights that Assignor has enjoyed thereunder as a result of the Mark and Registrations and otherwise, including, without limitation, all rights and interests in and to the Mark and/or Registrations (including the right to sue and defend against third parties for such infringement).

Assignor hereby certifies and agrees that he will, at any time, on request, execute and deliver any documents and instruments that may be necessary or desirable to perfect the title to the above-mentioned assets, and to carry out the terms of this Assignment.
