TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of July 25, 2007, is made by Bank of America, N.A., as Administrative Agent (the "Secured Party").

WHEREAS, each of Claremore Regional Hospital, LLC, Surgicenters of America, Inc., Doctors' Hospital of Laredo, Limited Partnership, Eye Institute of Southern The Arizona PC Arizona, El Dorado Medical Center, LLC (Owner of El Doral Hospital) and Northwest Hospital, LLC (Owner of Northwest Hospital), Medical Center of South Arkansas, San Diego Hospital, L.P., Overland Park Regional Medical Center, The Women's Healthcare Group, and Quorum Health Resources, Inc. (each the "Grantor", and together, the "Grantors") has granted a security interest in certain personal property to the Secured Party, including without limitation a security interest in certain trademarks, trademark applications, and/or trademark licenses ("Trademarks");



3. all products and proceeds of the foregoing, including, without limitation, any claim by the Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
