The Commissioner of Patents and Trademarks is requested to issue the Certificates of Registration to Assignee.

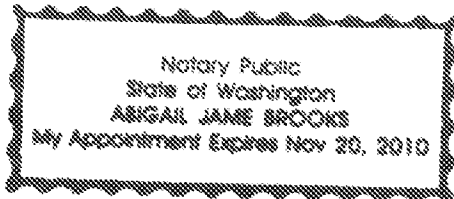
