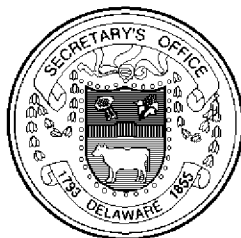

comScore Networks, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "**Corporation**"), does hereby certify that:

1. The name of the Corporation prior to filing this Certificate of Amendment of the Seventh Amended and Restated Certificate of Incorporation is comScore Networks, Inc., originally incorporated as comScore, inc. The original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on August 18, 1999.

2. The amendment herein set forth has been duly approved by the Board of Directors of the Corporation and by the stockholders of the Corporation pursuant to Sections 141, 228 and 242 of the General Corporation Law of the State of Delaware ("**Delaware Law**"). This amendment was approved by a written consent signed by the stockholders of the Corporation pursuant to Section 228 of Delaware Law.

4. The text of Article I of the Corporation's Certificate of Incorporation is hereby deleted and amended in its entirety to read as follows:

"The name of the Corporation is comScore, Inc."
