RELEASE AND TERMINATION OF SECURITY INTEREST

THIS RELEASE AND TERMINATION OF SECURITY INTEREST (this "Release") is made effective as of September 26, 2007 by The 1818 Mezzanine Fund II, L.P. ("1818 Fund"), a Delaware limited partnership, and Sioux City, L.P. ("SCLP"), a Delaware limited partnership, for the benefit of Long Lines, LLC ("Long Lines"), a Delaware limited liability company, and their respective successors and assigns.

Recitals

WHEREAS, 1818 Fund and Long Lines are parties to that certain Intellectual Property Security Agreement dated as of July 31, 2006 (the "Long Lines Security Agreement") and recorded in the United States Trademark Office at Reel/Frame number 3374/0344;

WHEREAS, pursuant to the Long Lines Security Agreement, 1818 Fund holds a security interest in and to certain intellectual properties owned or licensed by Long Lines, including, without limitation, the intellectual properties listed on Schedule A attached hereto (collectively referred to herein as the "Long Lines Intellectual Property Collateral"), arising out of the Long Lines Security Agreement and related documents; and

WHEREAS, 1818 Fund wishes to release its security interest in and to said Long Lines Intellectual Property Collateral;

WHEREAS, SCLP is the assignee of certain obligations of Long Lines, the repayment of which is secured by the Long Lines Intellectual Property Collateral, and wished to release any interest that it may have in and to said Long Lines Intellectual Property Collateral.

NOW, THEREFORE, in consideration of the foregoing premises and of other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree, as follows:

1. As of the date of this Release, 1818 Fund does hereby terminate and release any lien, claim, encumbrance or interest in and to the Long Lines Intellectual Property Collateral, which at least includes certain utility trademarks listed in the United States Patent and Trademark Office records at Reel/Frame number 3374/0344.
2. 1818 undertakes and agrees to do all acts and things and/or execute any further documents as Long Lines may reasonably request to carry into effect or to give legal effect to the provisions of this Release.
3. This Release may be executed in counterparts, each of which shall be

deemed to be an original, but all of which together shall constitute a single agreement.


4. This Release may not be changed except in a writing signed by the party against whose interest such change shall operate. This Release shall be governed by and construed under the laws of the State of New York applicable to contracts made and to be performed entirely within such State, without regard to principles of conflicts of law.
