## TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is made and entered into by and between National City Corporation ("National City") and First Franklin Financial Corporation ("First Franklin"), with an effective date of December 30, 2006 (the "Effective Date").

WHEREAS, National City and Merrill Lynch & Co., Inc. previously have entered into agreements concerning Merrill Lynch's acquisition of First Franklin's origination franchise and related servicing platform from National City, including the assignment from National City to First Franklin of certain intellectual property assets pertaining to said business; and

WHEREAS, National City is the record owner on an application pending before the United States Patent and Trademark Office for the word mark BEST SCORE, Serial No. 78,907,241, as used in relation to banking services (the "Best Score Mark"); and

WHEREAS, National City also is the record owner on an application pending before the United States Patent and Trademark Office for the word mark LITE CREDIT, Serial No. 78,930,057, as used in relation to banking services (together with the Best Score Mark, the "National City Marks"); and

WHEREAS, to the extent it was not previously documented, National City and First Franklin desire to memorialize the conveyance, transfer, and assignment to First Franklin of all of its right, title, and interest in and to the National City Marks, together with the goodwill of the business symbolized thereby in connection with the services on which the National City Marks are used;

NOW, THEREFORE, in consideration of the mutual promises set forth below and for other good and valuable consideration, the receipt of which is hereby acknowledged, National City and First Franklin hereby agree as follows:

1. **Assignment.** As of the Effective Date of this Agreement, National City hereby sells, assigns, transfers and conveys to First Franklin the entire right, title, interest in and to the National City Marks in the United States and all jurisdictions outside the United States, together with the goodwill of the business connected with and symbolized by the National City Marks (including, without limitation, the right to renew any registrations included in the National City Marks, the right to apply for trademark registrations within or outside the United States based in whole or in part upon the National City Marks, and any priority right that may arise from the National City Marks), the same to be held and enjoyed by First Franklin as fully and entirely as said interest could have been held and enjoyed by National City had this sale, assignment, transfer and conveyance not been made.
2. **Recordation, Necessary Documents.** National City authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and in any applicable jurisdictions outside the United States to record the transfer of the registrations and/or applications for registration for the National City Marks to First Franklin as assignee of National City's entire right, title and interest therein. National City agrees to further execute any documents reasonably necessary to effect this assignment or to confirm First Franklin's ownership of the National City Marks.

3. **Multiple Copies.** This Agreement may be executed by the parties hereto in separate counterparts, each of which when so executed and delivered shall be an original, but all such counterparts taken together shall constitute one and the same instrument. Each counterpart may be delivered by facsimile transmission, which transmission shall be deemed delivery of an originally executed document.


