Assignor hereby agrees, upon request of Assignee, and without further remuneration, to promptly provide Assignee with any reasonable assistance relating to perfecting the transfer of all of the rights conveyed herein and vesting of full and complete title in Assignee, and relating to enforcing and defending those rights, including but not limited to executing any and all papers for those purposes and testifying.

Assignor hereby authorizes the Director of United States Patent and Trademark Office to record this Assignment in connection with trademark application, United States Serial No. 78/746,202, for the sole benefit of Assignee, its successors, assigns, and legal representatives.
