TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of April 6, 2007, by **BANK OF AMERICA, N.A. (as successor by merger to Fleet National Bank)** (the "Lender"), with an office at 100 Federal Street, Boston, Massachusetts 02110, in connection with Credit Agreement dated as of July 21, 2004 (as heretofore amended, and in effect, the "Credit Agreement"), by and between Finlay Printing, LLC (the "Borrower") and the Lender.

WHEREAS, in connection with the Credit Agreement, the Borrower and the Lender entered into a Trademark Security Agreement, dated as of July 21, 2004 (the "Trademark Agreement"), which Trademark Agreement was recorded on March 1, 2005 with the United States Patent and Trademark Office at Reel 003036, Frame 0620 for the purpose of securing payment and performance of the Obligations (as defined in the Credit Agreement);

WHEREAS, pursuant to the Trademark Agreement, the Borrower granted to the Lender a security interest in, and granted, assigned and conveyed to the Lender, by way of collateral security, the Borrower's entire right, title and interest in and to, the trademarks listed on Exhibit A hereto (the "Pledged Trademarks"); and

WHEREAS, the Lender has agreed to terminate and release the Trademark Agreement and assign and transfer to the Borrower its right, title and interest in the Pledged Trademarks as herein provided;
